Sir,

With reference to your application on the subject noted above, I am directed to grant recognition to your school from class Ist to VIIIth (without aid) w.e.f. 1990-91 session subject to the fulfillment of the following terms and conditions :-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973, framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Inderpuri area.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department and in accordance with the provisions of Rule 26 of Delhi School Education Rules, 1973, and unqualified staff shall be replaced by qualified staff, if any.
4. That the school shall equip the Science Laboratory as per the norms of the Department and suitable facilities for practical work shall be provided to the students. More material shall be purchased in October, 1990, and a list be furnished to Education Officer for verification.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately. More books may be purchased by October, 1990, and the list of books be furnished to Education Officer for verification.

6. That adequate sports materials shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973, and payment to all the employees shall be made as per Section 10(1) of D.S.E.A. 1973, thereby making payment of Pay and Allowances as are being paid to the teachers in Govt. schools. The payment may be made by crossed cheques.
8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class. Number of the existing sections should not exceed the number of the class room of proper size in the school.
9. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
10. That all the conditions under Rule 50 and 51 would be fulfilled before 31st October, 1990, and provisions of Rules 6, 7 and 9 be strictly observed.
11. That the arrangement for potable water shall be made available to all the students as well as teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local body within a month.
12. That the service contract between the management and the employees shall be executed immediately.
13. That the pre-nursery and nursery classes will not run within the premises of Middle school building.
14. That the basement in the school should not be used for running classes in any way.
15. That the school premises should remain separate from other units of the Society such as Dispensary, X-Ray Room, Public Reading Room etc.
16. Entry gate of the school should be separate.

17. That the violation of any instructions/orders/conditions/Rules and Regulations of the Department either in part or in toto shall lead to the withdrawal of recognition of the school.
18. That the Class IXth shall not be opened in the school without the prior written approval of the Director of Education, Delhi.
19. That a report about the fulfillment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six months.
